#### URBAN COMMUNITY FOOD PROCESSING COMPLEX

The \$5.7 million **Community and Urban Food Complex**, a nearly 17,000- square-foot building, will have a research component, with state-of-the-art laboratory space for the food scientists; an educational component, with classrooms and areas for students to do research; and a collaborative component, with meeting rooms. It will also house a small-business incubator and an expanded dairy, capable of creating A&T branded dairy products such as ice cream, yogurt and butter, designed to merge the knowledge of university's students and researchers with the needs of the farmers they serve.




- The Brownfield Agreement has been executed, and the University is operating temporarily under and environmental management plan that has been approved by NC DEQ and will be used during the design and construction of the stadium.
- The documentation has been sent to the NC State Property Office. They will oversee the title transfer presentation to the Governmental Operations Committee State Property Office, the Council of State and Office of the Governor for final approval.
- The Council of State approved the transfer of War Memorial Stadium to the University on 6 June, 2021.
- The State Property Office is preparing the package for closing and anticipates being completed by the first of July.
- Once the title is in NC A&T's name the renovation process can then begin. The first step will be to hire a designer that is experienced in the design and construction of sports venues, and the restoration of historical venues.
