ANNUAL REPORT FROM THE CHANCELLOR’S COUNCIL ON INTERCOLLEGIATE ATHLETICS TO THE CHANCELLOR AND BOARD OF TRUSTEES

UNIVERSITY POLICY

Pursuant to University of North Carolina Policy Manual 1100.1 and 1100.1.1[R], the Chancellor’s Council on Intercollegiate Athletics shall annually prepare and present a written report to the Chancellor on or before September 1. This report shall include, at a minimum, the following elements:

1. A statement regarding the mission and vision of the Department of Intercollegiate Athletics;
2. A description or representation of Departmental organization and philosophy, including the reporting structure for athletics compliance and whether and to whom the athletics compliance director reports outside the Department;
3. A copy of the admission policy for student-athletes, including the definitions utilized for exceptions to the established admission criteria articulated for students generally;
4. A report on the academic performance of any student-athletes admitted as exceptions to the established admission criteria articulated for students generally, listed by sport;
5. Student-athlete academic profiles, including SAT/ACT score, high school grade point average, classification, and major;
6. A summary of all NCAA infractions reported during the year and the status of their resolution;
7. A review of the Department of Intercollegiate Athletics’ compliance with all Departmental policies;
8. A review and analysis of the Department’s fiscal position and stability, including a review of the annual athletics budget and major sources of revenue and expenses;

9. A review of the Departmental compliance with all existing Plans for Improvement developed as part of an Academic Progress Rate waiver process;
10. A review of the degree to which student-athletes are successfully integrated into campus life and are able to access co-curricular activities;
11. A review of the effectiveness of Departmental programs and activities designed to support the emotional, physical, and mental health of student-athletes;
12. A review of the Departmental structures and systems designed to prevent, mitigate, treat, and rehabilitate athletics injury, including a summary of the number and types of injuries sustained;
13. A review of the current year and five-year trend data for the NCAA Financial Dashboard and Comparative Data', to include, at a minimum, the following:
 - NCAA Academic Progress Rate
 - Generated Revenue/Total Athletics Revenue (%)
 - Net Athletics Revenue (\$)
 - Total Athletics Expenditures (\$)
 - Student Fees as a % of Revenue
 - Salaries and Benefits (%) (as a share of Total Athletics Expenditures)
 - Athletics Expenditure/Student Athlete (\$)
 - Athletics Expenditures/Institutional Expenditures (%)
 - Athletics Expenditure Rate of Change/University Expenditure Rate of Change (%)
14. A review of the current year Equity in Athletics Disclosure Act report and the NCAA Membership Financial Data Report(s).
15. Team Academic Progress Rate information, including six-year graduation rates, student-athlete GPA comparison as set out in UNCS Policy 700.6.1[R], and course-clustering information as set out in UNCS Policy 700.6.1.1[G]; and
16. Information regarding booster club organization and activity, including financial information, operating procedures, and annual audit reviews

The Chancellor, or designee, shall provide a copy of this report to the Board of Trustees during the Board's second meeting each fall.
