As a student traveling in association with North Carolina Agricultural and Technical State University (NCATSU), I understand the importance of representing NCATSU with adherence to the entirety of the Student Code of Conduct.

While representing NCATSU I know the following is expected:

- 1. Must be enrolled for the current semester and verified by an advisor.
- 2. Practicing civility, common courtesy, and respect. While refraining from the use of profanity.
- 3. Maintain an appropriate public appearance (no headwear that is nonreligious) nightwear/ undergarments being worn or see in public, appropriate length of clothing, no low pants, etc.).
- 4. Being sensitive to time, as travel times to and from events are prompt. It is expected that you will show up for all activities in a timely manner, as lateness could result in being left behind.
- 5. Remembering to practice etiquette when in public spaces. At restaurants a 15-20 percent tip is required. If a bellhop handles your bags, a tip is expected as courtesy; if you are unable to tip please decline the service. Remove hats when eating at a table or formally engaging with others.
- 6. Do not order room service or make any calls on hotel phones. Any charges outside of room/tax will be your responsibility (You will have to put your own credit card on the room for incidentals, if you require these services).
- 7. Being mindful of other guests at hotels in terms of noise and other public venues/facilities. No running and horse playing in spaces.
- 8. Understanding that at professional events you should refrain from chewing gum, and be mindful about the image you are portraying.
- 9. For your safety, please do not go anywhere alone; this includes wandering around hotels, events, the city, or etc. Please let your chaperone, advisor, team-leader, and peers know who you are going with and leave your cell number.

In acknowledgement of the gravity of the above, I solemnly pledge to conduct myself in a manner that reflects the prestigiousness of the University. Should I violate NCATSU Student Code of Conduct, or any other NCATSU policies applicable to student behavior, I understand that NCATSU may take conduct action against me prior to or upon my return to campus, at the discretion of the University.
